- » July 10: The Board of Directors of Inission AB resolved on a directed share issue through set-off against a receivable related to the acquisition of UAB Selteka.

CEO review

Balanced growth and recovery

The development seen in the second quarter of the year continued into the third. The Inission EMS business area is now showing clear and stable growth. For the Enedo OEM business area, the decline compared to the previous year continued, but, in sequential terms, there was positive improvement. Our latest addition to the Group, UAB Selteka in Lithuania, realised its first quarter as part of Inission, and made a valuable contribution to the overall performance. We are pleased to see that Inission grew by 13.5 (-9.1), percent of which 4.0 (-15.5) percent was organic growth. Net turnover during the quarter amounted to MSEK 531.1 (467.9).



There were also clear differences between the business areas in terms of profitability. Inission EMS showed stronger profitability, both compared to the previous year and the previous quarter. Enedo OEM, on the other hand, showed a negative EBITA result. Overall, EBITA for the quarter amounted to MSEK 28.5 (26.6), corresponding to an EBITA margin of 5.4 (5.7) percent. The low net financial items contributed to the result before tax being clearly better than the previous year.

The load factor of the factories followed for the most part the same pattern as in the previous quarter. Some units have a high load factor and are expanding, while others have a lower load factor and need to adjust their costs. Orders developed positively in line with sales, and resulted in an order/invoice ratio of 1.1 (1.0). In absolute terms, this corresponds to MSEK 577.6 (464.0), which is also an improvement compared to the second quarter of MSEK 516.9. The increased inventory and higher accounts receivable meant that cash flow from operating activities amounted to MSEK 3.6 (-39.6).

Business area Inission, EMS

Turnover for the quarter amounted to MSEK 449 (355), representing a strong development, where acquisitions accounted for 12.5 percent of the growth and organic growth amounted to 13.9 percent. It is encouraging that the market has clearly recovered since the end of the second quarter, which is now also reflected in our results.

Despite the increased delivery rate, we were able to close most factories for two weeks' holiday, which gave our employees much-needed recovery time.

Our commitment to offering competitive production from Tunisia continues unabated. During the conclusion of the change project, an interim MD guided the work forward with tremendous commitment. In September, we were pleased to welcome Ali Blel as the new permanent MD of Inission Tunis. Ali has a degree in industrial economics and an MBA, as well as extensive leadership experience from his years at APEM and CAVEO. His strategic thinking, determination, and strong communication skills will be valuable assets in building a stable and successful future for Inission Tunis.

We are also continuing to invest for the future in Finland. A new automated bending machine has been ordered and will be fully integrated with the existing equipment from the same supplier. This is an important step towards our vision of a fully automated production line for sheet metal products, an area where we see great potential.

EBITA for the quarter amounted to MSEK 35 (22), corresponding to an EBITA margin of 7.7 (6.3) percent. The margin for the last twelve months equals 6.2 percent. The result reflects both strong teamwork and the improvements we have implemented during the year.

Business area Enedo, OEM

Turnover for the third quarter amounted to MSEK 81.8 (114.8), corresponding to a decrease of 28.7 percent. The lower volume negatively affected the result, and EBITA amounted to MSEK -6.1 (4.3), corresponding to an EBITA margin of -7.4 (3.8) percent. The order book grew during the third quarter.

Orders continued to increase compared to the previous year, with an order/invoice ratio of 1.3 so far this year. Demand for power supply products from key industrial OEM customers are showing a gradual recovery. During the quarter, activity was also high in the defence and infrastructure segments, where Enedo secured several significant orders, including approximately 150 rack-based DC systems for mobile power distribution stations in the US, and the first order for a newly launched system cabinet solution for the Swedish energy market.

Enedo has now become a company with a clear focus on the sale and development of power supply products and systems. The organisational restructuring was completed in order to strengthen focus and permanently reduce operating costs. One-time costs related to this amounted to MSEK 3.7 during the quarter. The company also worked actively during the quarter to develop new products, with the goal of offering customised power supply solutions and broadening the portfolio of DC systems for critical infrastructure applications.

Acquisitions

Work has begun to integrate Selteka into Inission. This is not a major reshuffle, according to our model with decentralised subsidiaries. We usually say that at Inission we prefer evolution to revolution. This means that our observations from the due diligence process are now being converted into an integration plan that is being implemented incrementally. Selteka has a well-developed and driven production strategy, where, in many respects, they have come further than many of Inission's other factories. It is important that this is put into use and disseminated further within the Group.

Regarding acquisitions, we continue to work calmly and methodically in line with our strategy. Our goal to grow by an average of 5% per year through acquisitions over a three-year period remains unchanged.

Ahead

Just when it seems the turbulence surrounding the trade agreements with the US is starting to subside, new developments are arising that, once again, fuel the uncertainty. The geopolitical unrest and subdued industrial economy remain. However, fears of a backlash following pre-orders in the first half of the year, to avoid tariffs, have not been realised. Instead, we are witnessing a clear recovery among our customers, both within Inission EMS and Enedo OEM.

A stronger industrial economy is likely to come; the only question is when it will really gain momentum. Inission EMS is expected to exceed its comparative figures, while Enedo OEM will probably face another quarter with lower sales. However, Enedo OEM has implemented cost savings, and is believed to have the conditions for a positive operating result from the first quarter of next year, despite the lower volume.

The long-term trends continue to speak for our industry: regionalisation, electronics as an enabler for a variety of applications, electrification, automation, and connected machines monitored by increasingly advanced AI programs.

Inission is a manufacturing partner with services and products that cover the entire product life cycle, from development and design to industrialization, volume production and aftermarket. Inission has production units in Stockholm, Västerås, Borås, Munkfors and Malmö in Sweden, Halden (AXXE AS) and Løkken Verk in Norway, Lohja in Finland, Kaunas (UAB Selteka) in Lithuania, Tallinn and Lagedi in Estonia with a total of 1 007 employees.

Net sales amounted to 449.3 MSEK, compared to 355.4 MSEK in the previous year. The increase in sales was +93.9 MSEK, of which acquired growth was 44.3. This means that organic growth was 13.9% (-15.5%). EBITA for the period amounted to 34.6 MSEK, compared to 22.3 MSEK in the previous year, corresponding to an EBITA margin of 7.7% compared to 6.3% in the previous year. The EBITA margin for the past 12-month period thus amounts to 6.2%.

Enedo is a product company that develops, manufactures, and sells high-quality electronic power supplies and system solutions. Enedo operates in Finland, Italy, the United States, and Tunisia, with a total of 259 employees.

Net sales amounted to 81.9 MSEK, compared to 114.8 MSEK for the corresponding period last year.

EBITA for the period amounted to -6.1 MSEK, compared to 4.3 MSEK last year, corresponding to an EBITA margin of -7.4% compared to 3.8% last year. Costs include expenses for staff reductions amounting to 3.7 MSEK.

Comments

INCOME STATEMENT, Q3 2025 (MSEK)

Group: Net turnover in the quarter amounted to 531.1 (467.9), which represents an increase of 13.5 (-9.1) percent in the quarter. The turnover includes Selteka, totalling 44.0. Other operating income amounted to 3.8 (-1.8). Change in inventory of work in progress and finished goods amounted to 1.1 (-9.0). The cost of raw materials and supplies, together with the change in inventory in the quarter, amounted to 289.4 (250.2), an increase of 15.7 (-18.7) percent. The material share, including material sales, taking into account the change in inventory, landed at a slightly higher level compared to the previous year, at 54.5 (53.5) percent.

Other external expenses for the period amounted to 51.4 (60.0). Personnel costs amounted to 139.4 (113.3), of which costs for restructuring amounted to 5.1. Other operating expenses amounted to 3.1 (-6.1). Depreciation and impairment of intangible and tangible fixed assets and right-of-use assets amounted to 24.0 (23.1). Overall, this gives an operating result for the Group of 27.7 (25.8), and a result after financial items of 22.0 (16.2), of which currency effects were -2.3 (-2.7). Other comprehensive income for the quarter amounted to -5.6 (-6.1). Total comprehensive income subsequently amounted to 11.5 (7.0), of which 11.3 (7.0) was attributable to the Parent Company's owners and 0.2 (0.1) to non-controlling interests.

Parent Company: The operating result for the third quarter amounted to -2.1 (-1.0).

INCOME STATEMENT, Q1-Q3 2025 (MSEK)

UAB Selteka was acquired on 30 June 2025, and is included in Inission's income statement in this report. Net turnover for the period amounted to 1 549.3 (1 618.5), which represents a decrease of 69.2 (4.3) percent. The turnover for the period includes Selteka, totalling 44.0. Other operating income amounted to 12.2 (5.3), and change in inventory of work in progress and finished goods amounted to 47.3 (-4.6). The cost of raw materials and supplies, together with the change in inventory in the period, amounted to 864.1 (918.1), a decrease of 5.9 (-6.9) percent. The material share including material sales, taking into account the change in inventory, is at a lower level compared to the previous year, 55.8 (56.7) percent; an improvement of 0.9 percent.

Other external expenses for the period amounted to 144.2 (152.7), of which costs for the list change amounted to 4.9 (0.5). Personnel costs amounted to 410.7 (381.0), of which restructuring costs amounted to 6.9. Other operating expenses amounted to 3.4 (-6.1). Depreciation amounted to 69.0 (66.7).

Overall, this gives an operating result for the Group of 70.0 (104.6), and a result after financial items of 44.2 (78.8), of which currency effects were -11.5 (-0.1). Other comprehensive income for the period amounted to -16.3 (1.2), as a result of the strengthened Swedish krona. Total comprehensive income subsequently amounted to 15.4 (65.6), of which 15.0 (65.1) was attributable to the Parent Company's owners and 0.3 (0.5) to noncontrolling interests.

BALANCE SHEET, Q3 2025 (MSEK)

UAB Selteka was acquired on 30 June 2025, and is included in Inission's income statement in this report. The acquisition entailed an increase in goodwill of 24.9. Goodwill amounted to 233.3 (213.0), and, excluding goodwill in relation to Selteka, the decrease comes from currency translation. Other intangible assets amounted to 88.2 (94.7), and licences amounted to 2.6 (5.0). The total value of tangible fixed assets has increased to 132.3 (101.1), mainly related to Selteka and investments in production equipment, reduced by depreciation and changes in exchange rate.

Right-of-use assets amounted to 205.1 (236.6), and the change relates to new and terminated leases less depreciation, newly signed leases, and changes in exchange rates. Financial assets amounted to 5.7 (4.6). Inventory amounted to 620.5 (596.1), of which Selteka totalled 36.8, an increase of 4.7 percent compared to the previous year. Accounts receivable amounted to 398.4 (408.7), a decrease compared to the previous year. This is a natural consequence of the fact that we have ceased invoice financing and invoice sales, with an impact of approximately 80.0, and additional receivables through the acquisition of Selteka, totalling 18.9.

Total assets decreased during the quarter, from 1 800.6 to 1 798.5 (1 734.3). Compared with the previous year, this entails an increase of 83.6. Total equity amounted to 685.6 (656.0), of which non-controlling interests amounted to 2.6 (2.2). Equity increased, mainly through the private placement that was carried out as a result of the acquisition of Selteka, where 25 percent of the purchase price was paid with Inission shares. This means a continued strong equity ratio of 38.1 (37.8) percent. Long-term liabilities increased

in conjunction with the acquisition and, reduced by amortisations, subsequently amounted to 331.3 (351.0), and compared with the previous year decreased by 19.7, corresponding to 5.6 percent. Short-term liabilities amounted to 781.6 (727.3).

In order to reduce the currency effect, Inission AB continuously purchases futures in US dollars and EUR. The Company hedges up to 80 percent of the Group's future net outflow. In the case of currency hedging, the hedging instruments are revalued to fair value on the balance sheet date in the event of changes in exchange rates. The value of these futures at the end of the quarter amounted to 0.2 (-0.4). This is recognised under financial items in the income statement.

CASH FLOW

Cash flow from operating activities in the quarter amounted to 3.6 (-39.6), and for the period totalled 77.4 (-62.5). Cash flow from operating activities has improved, mainly with regard to working capital, both in the quarter and the period compared to the previous year.

Stock Option Programs

Employees and the Board of Directors have in recent years been offered participation in several stock option programs with a term of three years. See further details in Note 7. In connection with the listing switch, Inission prepared a prospectus which was approved by the Swedish Financial Supervisory Authority on April 14, 2025. Trading in Inission's Class B shares commenced on April 28, 2025, with the unchanged ticker symbol (INISS B) and ISIN code (SE0016275069).

In addition, we have assessed and reported the additional purchase consideration related to the acquisition of AXXE. According to the terms, the final amount may be adjusted depending on AXXE's performance over the next two years. See page 85, Note 36, in the 2024 Annual Report. We assess that control of Selteka was obtained on June 30, as the purchase consideration was paid and a loan was raised on the same day.

SIGNIFICANT RISKS AND UNCERTAINTIES

In preparing the interim report, the company has reviewed the material risks and uncertainties as described in the 2024 Annual Report and has assessed that no significant changes have occurred. For further information, please refer to page 58 of the 2024 Annual Report. However, invoice sales and invoice financing have not been used since the beginning of the fourth quarter 2024. Our segments within electronics and power supply have limited exports to the U.S., but like many groups, we face increasing risks related to tariffs, rules of origin, and regulatory uncertainty.

Currency fluctuations and potential delivery delays may negatively affect both margins and cash flow. Strategically, we work with currency hedging, documentation routines, maintain some local presence in the U.S., and cooperate closely with our customers. Proactive risk management is essential to ensure competitiveness and stable exports to the U.S. market.

Notes

Note 1 - Company information

Inission AB (publ), corporate ID number 559259-1890, is headquartered in Karlstad, Sweden. The company's main office is located at Lantvärnsgatan 4, SE-651 22 KARLSTAD, phone number +46 54 771 93 00. Inission's Class B shares, with ticker symbol (INISS B) and ISIN code (SE0016275069), have been listed on Nasdaq Stockholm Main Market since April 28, 2025. The company's operations, including its subsidiaries, are described in the 2024 Annual and Sustainability Reports. The parent company, Inission AB, is fully focused on the management and development of the Group. The parent company's revenue consists almost exclusively of sales of management services to the subsidiaries. Purchases from the subsidiariesare not significant.

Note 2 - Accounting principles

This interim report has been prepared in accordance with IAS 34, Interim Financial Reporting, and the Parent Company's report has been prepared in accordance with Chapter 9 of the Swedish Annual Accounts Act (ÅRL). The accounting principles applied are unchanged compared with those described in the 2024 Annual Report. The consolidated financial statements for Inission AB (publ) have been prepared in accordance with the International Financial Reporting Standards (IFRS) and related interpretations (IFRIC) as adopted by the EU, the Annual Accounts Act, and the recommendations of the Swedish Financial Reporting Board RFR 1 Supplementary Accounting Rules for Groups.

The Parent Company's financial statements have been prepared in accordance with the Annual Accounts Act and RFR 2 Accounting for Legal Entities. Disclosures in accordance with IAS 34.16A are provided, in addition to the financial statements and related notes in the interim information, on pages 5–9, which form an integral part of this financial report. All amounts in this report are stated in millions of Swedish kronor (MSEK) (previously thousands of Swedish kronor, TSEK), which is the company's reporting currency unless otherwise stated.

Rounding differences may occur in tables and calculations, meaning that reported totals may not always equal the sum of the rounded figures.

The company has reviewed its principles for handling foreign exchange effects related to operations. As of Q2, foreign exchange gains and losses are reported net by group company as Other operating income (net exchange gain) or Other operating expense (net exchange loss), including the effect of forward contracts. Prior periods have not been restated since operating profit remains unchanged and the reclassification is not considered material.

Going concern

The company's financial statements have been prepared based on the going concern assumption, meaning that the company is considered capable of continuing its operations in the foreseeable future. In making this assessment, the Board and management have considered the company's financial position, liquidity, access to financing, and expected cash flows. No circumstances have been identified that would indicate the company's inability to meet its payment obligations as they fall due. Therefore, there is no reason to prepare the financial statements using any other accounting principle.

Note 3 - Segment Information and Disclosure on Net Revenue

The Group's chief operating decision maker is the CEO, who evaluates the operating segments' results based on the type of production and business. The CEO monitors EBITA monthly as the primary performance measure, but EBIT and EBITDA are also tracked. EBITA is viewed as a complement to operating profit and aims to measure the underlying result from ongoing operations, excluding depreciation and impairments of intangible assets. The Group's operations are managed

and reported according to the following operating segments:

Inission EMS – Contract Manufacturing of Electronics and Mechanics

Inission is a manufacturing partner offering services and products covering the entire product lifecycle, from development and design to industrialization, volume production, and aftermarket. Inission has production units in Stockholm, Västerås, Borås,

Munkfors, and Malmö in Sweden; Halden and Løkken Verk in Norway; Lohja in Finland; Kaunas in Lithuania as well as Lagedi and Tallinn in Estonia, employing a total of 1,007 employees.

Enedo OEM – Power Supply and Systems

Enedo is a product company that develops, manufactures, and sells high-quality electronic power supplies and system solutions. Enedo operates in Finland, Italy, the USA, and Tunisia, with a total of 259 employees.

Sales between segments occur on market terms and are adjusted upon consolidation. The amounts provided to the CEO regarding segment revenues are measured in a manner consistent with the financial statements. The Group's primary revenue streams are from the sale of goods. There are no customers whose revenues individually represent more than 10% of the Group's total revenues.

Note 4 - Loan terms and covenants

The company has entered into loan agreements that include financial covenants. These covenants are continuously monitored to ensure compliance and are reported to Nordea Bank Plc once per quarter.

Net debt/EBITDA: The company must maintain a net debt-to-EBITDA ratio below 3.0x. EBITDA is measured on a rolling 12-month basis.

Equity ratio: The company must maintain an equity ratio exceeding 30%.

If the company fails to meet these requirements, the lender may have the right to demand early repayment of the loans. As of September 30, 2025, the company's net debt/EBITDA ratio was 2.9x, and the equity ratio was 38.1%. The company assesses that there is no material risk of breaching the covenants during the coming twelve-month period.

In the event of any non-compliance, it may also be necessary to renegotiate the terms with the lenders.

If the company were not to meet the covenants at the balance sheet date, it would have the option to utilize a formal waiver, meaning that the loans would not become immediately due as a result of such a waiver.

If, at the balance sheet date, the company had failed to meet its covenants and had not obtained a waiver, the loans would be reclassified as current liabilities. The company assesses the likelihood of future covenant breaches as low.

For assets and liabilities measured at amortized cost, the Company assesses that the carrying amount of its receivables and liabilities corresponds to their fair value. Since the company's receivables and liabilities mainly have short maturities and liabilities to credit institutions carry variable interest rates, the difference between carrying amount and fair value is deemed negligible.

The remaining contingent purchase consideration to be paid for AXXE in cash is conditional on financial performance improvements. The variable and projected purchase price for the remaining 49.9% of the shares is determined as EV = 6x EBITDA based on AXXE's average results from 2024 through January 2027. The liability in the Group's balance sheet represents management's best estimate of the expected future cash flow. This assessment is made at the subsidiary level and is regularly revalued. The fair value of the contingent

purchase considerations has been calculated based on the expected outcome of the contractual targets. This estimated value has not been discounted as the discounting effect is not considered material. If AXXE's results increase by 10% more than estimated, this would mean an increase in the contingent purchase consideration of approximately 4 MSEK, and conversely, if their results are lower than estimated, the contingent consideration would decrease accordingly.

Input and assumptions for fair value measurement of interest rate and currency derivatives

The company obtains and uses information from Nordea in valuing interest rate and currency derivatives at fair value. These inputs include market interest rates, exchange rates, and other relevant parameters provided by the bank. The information is used in applying established valuation techniques, such as discounting of future cash flows, to determine fair value. The company considers these inputs to be observable market data and thus classifies the derivatives within Level 2 of the fair value hierarchy.

Note 6 - Business acquisitions

BUSINESS ACQUISITIONS DURING THE PERIOD 2025-01-01 TO 2025-09-30 (MSEK)

During the period from January 1, 2025, to September 30, 2025, the Group completed one acquisition.

On June 30, 2025, Inission AB entered into an agreement to acquire all shares in UAB Selteka, located in Kaunas, Lithuania, of which 6.0 MEUR (66.9 MSEK) was paid upon closing. The cash consideration paid, net of acquired cash as of June 30, amounted to 58.8 MSEK. At the time of closing, 4.0 MEUR was financed through a bank loan corresponding to half of the purchase price. The remaining 2.0 MEUR was settled through newly issued shares, a total of 636,940 shares at a price of SEK 34 per share. Transaction costs amounted to 0.1 MSEK and are recognized in the consolidated and parent company income statements under Other external costs.

The table on the right summarizes the purchase consideration for UAB Selteka as well as the fair value of acquired assets and assumed liabilities. The purchase price allocation is preliminary and may be subject to change regarding the calculation of goodwill.

Goodwill: Goodwill is primarily attributable to synergies. No part of the recognized goodwill is expected to be tax-deductible.

Net sales and earnings of the acquired business: The results from the acquired operations are consolidated as of July 1, 2025. If the acquisition had been completed on January 1, the consolidated pro forma for revenues and earnings as of September 30 would amount to 130.3 MSEK and 7.8 MSEK, respectively.

Note 7 - Warrant programme

WARRANT PROGRAM 2025

In 2025, employees and members of the Board of Directors were offered to acquire warrants enabling them to purchase shares in Inission during the period June 19 – July 14, 2028. The exercise price per warrant amounts to 37.64 SEK. The warrants were acquired at fair value at the time of acquisition (9.32 SEK). Of this amount, 50% was subsidized by Inission at the time of acquisition, and the remaining 50% of the purchase price will be subsidized by Inission provided that the employee remains employed until the exercise date. The fair value of the warrants was determined using the Black & Scholes valuation model with a volatility of 53.64%. During the period, the Group has subsidized the warrant program with 0.2 MSEK.

Inputs to the valuation according to the Black & Scholes model for the 2025 program are:

- Share price: 33.6 SEK, based on the closing price as of May 21, 2025.
- Exercise price: 37.64 SEK, corresponding to 115 % of the volume-weighted average share price between May 8 and May 21, 2025.
- Term: 3.15 years (until July 14, 2028).
- Risk-free interest rate: Estimated using Swedish market rates as of May 21, 2025; 1.98%.
- Volatility: 53.64%, based on a three-year average of 30-day volatility.

- Expected annual dividend yield: 2.98%, applied in the valuation of the warrant in line with management's expectations.
- Market illiquidity discount: 20%, applied in the valuation of the warrant in accordance with market practice and empirical studies of illiquid options.

WARRANT PROGRAM 2024

In 2024, employees and members of the Board were offered to acquire warrants enabling them to purchase shares in Inission during the period from June 21 to July 16, 2027. The exercise price per warrant amounts to 59.20 SEK. The warrants were acquired at fair value at the acquisition date (14.19 SEK). Of this amount, 50 % was subsidized by Inission at the time of acqui-sition, and the remaining 50% of the acquisition price will be subsidized by Inission provided that the employee remains employed until the exercise date. The fair value of the warrants was determined using the Black & Scholes valuation model, based on a volatility of 57%.

WARRANT PROGRAM 2023

In 2023, employees were offered to acquire warrants enabling them to purchase shares in Inission during the period from June 1 to June 12, 2026. The exercise price per warrant amounts to 74.90 SEK. The warrants were acquired at fair value at the acquisition

date (23.95 SEK). Of this amount, 50% was subsidized by Inission at the time of acquisition, and the remaining 50% of the acquisition price will be subsidized by Inission provided that the employee remains employed until the exercise date. The fair value of the warrants was determined using the Black & Scholes valuation model, based on a volatility of 57%.

WARRANT PROGRAM 2022

In 2022, employees were offered to acquire warrants enabling them to purchase shares in Inission during the period from May 20 to July 13, 2022. The exercise price per warrant amounts to 35.20 SEK. The warrants were acquired at fair value at the acquisition

date (11.39 SEK). Of this amount, 50% was subsidized by Inission at the time of acquisition, and the remaining 50% of the acquisition price will be subsidized by Inission provided that the employee remains employed until the exercise date. The fair value of the warrants was determined using the Black & Scholes valuation model, based on a volatility of 57%. Of the warrants issued under the 2022/2025 program, 20,680 have been exercised for shares, of which 16,680 by employees. A total of 21,420 warrants expired without being exercised. Compensation for the subsidized exercise price amounted to 0.3 MSEK. Equity increased by 0.9 MSEK.

Note 8 - Transactions with related parties

(MSEK)

Inission AB is the ultimate parent company preparing consolidated financial statements. No single party has controlling influence over Inission AB. The companies IFF Konsult AB and FBM Consulting AB, each of which has significant influence in Inission AB, are owned by key management personnel and are therefore considered related parties to Inission. Related parties also include all subsidiaries within the Group, as well as key management personnel and their close family members. Transactions are carried out on market terms. All transactions between Inission AB and its subsidiaries have been eliminated in the consolidated financial statements.

During the period, related parties subscribed for a total of 18,000 options, which were subsidised by 0.1 MSEK. Other related party transactions during the period refer to salaries and pension contributions. No other transactions with related parties have occurred during the period.

In connection with the acquisition of Selteka UAB, IFF Konsult AB and FBM Consulting AB provided guarantees to the bank to contribute capital to Inission AB, if necessary, of 15.0 MSEK each. This guarantee expired during the third quarter.

Note 9 - Reconciliation table and definitions

Inission uses financial measures that are not defined under IFRS but are considered alternative performance measures (APMs). These measures provide the reader with additional information and facilitate further analysis of the Group's performance over time. Below are reconciliations and explanations of the components included in the alternative performance measures used in this report. Reconciliation is made to the most directly reconcilable line item, subtotal or total presented in the financial statements for the corresponding period.

EBIT: Operating profit before financial income and expenses. The purpose is to measure the underlying result from ongoing operations.

EBIT margin: Operating profit as a percentage of net revenue. The purpose is to provide an indication of profitability relative to revenue.

EBITA: Results before financial income and expenses, taxes, and depreciation and amortization of intangible assets. The purpose is to measure the underlying result from ongoing operations, excluding amortization and impairment of intangible assets.

EBITA margin: EBITA as a percentage of net revenue. The purpose is to show the operational profitability of the business regardless of amortization and impairment of intangible assets.

EBITDA: Results before depreciation and amortization of intangible, tangible fixed assets, and right-of-use assets. EBITDA complements operating profit. The purpose is to measure the result from ongoing operations, excluding depreciation, providing a good measure in terms of cash flow.

EBITDA margin: EBITDA as a percentage of net revenue. The purpose is to provide an indication of profitability independent of depreciation and amortization of intangible, tangible fixed assets, and right-of-use assets in relation to revenue.

Net revenue growth: The change in the group's net revenue compared to the comparison period. The purpose is to show the total growth in net revenue for all group companies compared to the previous period.

Organic Net Sales Growth: Net sales (adjusted for acquisitions and divestments) minus net sales for the previous period. Net Debt: Long-term interest-bearing liabilities, long-term lease liabilities, short-term interest-bearing liabilities and short-term lease liabilities, less cash and cash equivalents. The purpose is to clarify the level of debt net of available liquid assets (which could theoretically be used to repay loans).

Net Debt/EBITDA: Net debt divided by EBITDA. The purpose of this ratio is, as one of two key figures, to ensure compliance with loan covenants. The ratio shows how many years it would take for the company to repay its net debt using the earnings (EBITDA) it generates each year.

Equity Ratio: Total equity as a percentage of total assets. The purpose is to assess financial risk and show the proportion of assets financed by equity. The equity ratio is one of two measures used to ensure compliance with loan covenants.

Order Intake: Total value of orders received during the period, measured at exchange rates as of the balance sheet date. The purpose is to provide information about the expected future demand for the company's products or services.

Order Book: Total value of outstanding orders at the end of the period. The purpose is to serve as an indicator of future sales and revenues, helping to forecast and plan operations.

Book-to-Bill Ratio: Order intake divided by net sales. A book-to-bill ratio above 1 indicates that the company is receiving more orders than it delivers, suggesting business growth and strong demand for the company's products or services.

RTM (Rolling Twelve Months): Used to measure results or key figures over the past 12 months, regardless of calendar year.
